Check Title – Look before you buy If you buy your car at a dealership, the dealer is required to fill out the title application on your behalf, so you won't have to visit the tax office. Make sure the dealer provides you with a receipt showing the vehicle that is heading to your name. This permit is valid for five calendar days and only one permit can be provided per vehicle sale. Get a Vehicle Transmit Permit If Purchased from a Person, a motor sales tax vehicle (6.25 percent) over either the purchase price or standard supportive value (regardless of which is the highest value), must be paid when the car is titled. The title, registration and local fees are also due. Contact your county tax office to estimate the sales tax amount and to learn what forms of payment are accepted. Acceptable forms of payment vary by count. Application Processing Time Please enable a minimum of 20 business days for treatment in your title application.
